Transformation of Indian Railways - Miles to go

Ever since the Bibek Debroy committee submitted its report on restructuring and reforming the Indian Railways, the transformation of the monolith railways has received due attention. Soon after the advent of liberalization in 1991, the reforms in infrastructure sector had become a necessity. However, during the first two decades, reforms in power and telecom sector received more attention. Reforms of railway sector were not much talked about. There were some attempts at privatization previously. Container Policy Liberalization which led to establishment of Container Corporation of India in 1989, The Own Your Wagon Scheme of 1992, Special Freight Train Operator Scheme, are some examples. These schemes were not successful. The first and the foremost reason was the structure of Indian railways itself, in which policy making, the regulatory function and operations are vested within the same organization. A typical case of conflict of interest, in which the policy maker and regulator is also a competitor. The user-hostile conditions of the schemes were another reason, for lack of success of privatization. The Indian railways which is the fourth largest railway network in the world with 20,000 trains, 21 million daily passengers, has made progress in terms of number of trains, passengers and freight carried. This however was not enough. Indian Railways, was saddled with problems of wide gap between demand and supply, politicization of decisions related to fares, introduction of trains, number of halts etc. Low employee productivity, lack of safety, were other problems. In other words, this was again the case of politics of populism gaining over sound economic principles. Commercial considerations took a back seat. Excess manpower, with inter departmental rivalry staring in its face, Indian railways, lacked business orientation. Burgeoning employee costs, put a strain on the already precarious financial status of the railways. Railways also perform certain functions like running hospitals and schools which is not required. Therefore, the need of radical transformation of railways was felt. It was decided to constitute a committee that would suggest measures for a radical transformation of railways. Bibek Debroy committee was constituted in September 2014, which submitted its report in June 2015.

It is beyond the scope of this write up to discuss each and every recommendation of the committee. Some of the very important recommendations, issues and concerns raised are highlighted here. One of the most important recommendations is, setting up of an independent regulator, the Railway Regulatory Authority of India (RRAI). This is one of the most debated and discussed recommendations. What would be the powers of the regulator? Should the regulator be given the power of determining the

passenger and freight tariff? How independent should it be? The committee recommends that the regulator should have tariff fixation power. The committee further recommends that RRAI should be set up statutorily, with an independent budget, so that it is truly independent of the Ministry of Railways. The RRAI will have the powers of granting access to railway infrastructure to private operators, licensing, setting technical standards. The issues and concerns raised in this regard, are many. Critics feel, the independence of RRAI may remain only on paper. The experience of an independent regulator in power sector is often quoted as an example for lack of faith in independent regulator. In power sector, independent regulatory commissions were established in states and one in Centre in the year 1998. Later on, the passage of Electricity Act in 2003, further gave powers to regulatory commissions. The commissions were supposed to remain independent from the ministry of power, in the matters of tariff setting. This has certainly not happened the way it was expected. The state governments continue to interfere in the matters of tariff setting, the goal of 'Rationalization of Tariffs' remains as elusive as ever in the power sector. It was further expected that through the provision of 'Open Access' competition in power sector will be become a reality, in which the consumers will choose their electricity distributors, from among the various suppliers in a state or city. The implementation of this provision also has remained tardy, as the state electricity distribution companies have thwarted this provision and prevented shift of consumers to new suppliers. The critics therefore opine that the independent regulator in railways may also meet the same fate. Will the tariff setting become free from politics? Will the regulator remain independent of the ministry in true spirit? Will the regulator be able to give a fair access to railway infrastructure to private operators without any interference from politics?

The other recommendations of the committee which have received due attention are regarding adoption of commercial accounting practices and doing away with archaic accounting practices, rationalization of human resources, lateral inflow of talent, doing away with centralized and hierarchical structure. There is an apprehension, whether this will really happen. Therefore it can be concluded that, recommendations are revolutionary, but till the implementation actually happens, there are miles to go, before the 160 year old organization is truly transformed.

After many decades of existence of public sector in India, there are still many questions unanswered. Though the Government has delegated financial and administrative powers to PEs(public enterprises) to a great extent to provide considerable financial leverage for taking prudent decisions, the results are not satisfactory. It has been several decades since the MoU system has been introduced in India in the hope of incentivizing performance, yet there are considerable numbers of PEs which are languishing in the fair and good category in terms of performance. Performance challenges still exist in public sector enterprises which are mainly due to inadequate systems, processes and latest technology. The focus now is on making the PEs more efficient and competitive so that they can face the stiff market competition. There is a clear direction that has been set with the Performance Management Division taking lead and rolling out the overarching PMS and implementing RFD. The RFD system provides a comprehensive framework of performance measurement and management for all the government departments/ministries, to develop performance plans in sync with the national priorities and programmes. With the RFD system in place, it will give greater stability to the MoU system and make it sustainable.

The research was led by Prof. R. K. Mishra, Project Director and the other team members were Dr. Punam Singh, Co - Project Director, Dr. Shulagna Sarkar, Co - Project Director, Ms. J. Kiranmai, Co - Project Director. They conducted a National level 'CSR in India' at IPE. The study was funded by ICSSR.

According to the Companies Act 2013, a company shall spend, in every financial year, at least two per cent of the average net profits of the company made during the three immediately preceding financial years in pursuance of its Corporate Social Responsibility Policy. The 12th five year plan aims to bring in inclusive growth, social inclusiveness being an integral aspect. The government initiatives are aimed at achieving social inclusiveness, which requires investment of huge money, resources and commitment from all stakeholders of the society. The government has taken initiatives in the past and is also actively involved in implementation of initiatives to meet the above objective. In view of the scale of resources required to meet the dream of social inclusiveness come true, it is important that organizations work hand in hand with the government. Synergizing the CSR initiatives of the organizations with the

initiatives of the government will be a positive and effective step in fulfilling the commitment for ensuring social inclusiveness.

In view of the above background, the national level exploratory study conducted by the Centre for CSR at Institute of Public Enterprise, Hyderabad aimed to understand the scope of CSR as a tool for social inclusiveness. The research focused on studying the existing CSR practices of organizations and also reflected on the role of various stakeholders in effective implementation of CSR. An impact assessment study was also conducted to understand the effectiveness of CSR.

This study was conducted in the backward districts of the four select states of the country representing the four zones. The need assessment study was conducted in the ST/SC majority villages of the backward districts of Telangana, Odisha, Rajasthan and Madhya Pradesh. A total of 1846 households were surveyed as part of this research. Both qualitative and quantitative data were collected as part of this study with the use of questionnaire, interviews and focus group discussions. Both primary and secondary data have been extensively used as a part of this research. Primary data was also collected from Corporate, local administration and NGOs to understand their perspective on CSR and also to understand the role they need to assume for effective implementation of CSR.

The study reflected that nearly 100% of companies are working in the area of education, 95% in the area of health, 90% in the area of livelihood, 95% in rural development and 85% in the area of environment. The organizations studied had a CSR policy in place and have also disclosed it on their websites. The study revealed that a majority of the large private sector companies are implementing their CSR through their own trust or foundations. In case of public sector companies, a majority of their projects are implemented through CSOs/ NGOs. The companies should be very careful in selecting the right NGOs. There is also a need to empanel NGOs by a central body so that companies have a list of NGOs in terms of credibility and expertise to choose from. The study also highlighted the importance of local administration in the effective implementation of CSR and also the implementation difficulties faced by organizations during CSR implementation. CSR in the proposed format as per the law is in its nascent stage and it will take at least 3 to 5 years for the impact to be measured.

It has been concluded that at the micro level, increasing income generation through livelihood initiatives, improving public infrastructure, healthcare, education, and women's empowerment supported through civil society organizations, good governance, and integrated initiatives of corporates can help accelerate poverty reduction. Access to basic facilities such as health, education, sanitation, drinking water helps to reduce exclusion thus opening the channel for social inclusiveness.
