



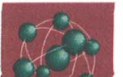

Sub: Incentives for Research Publications

To nurture an environment for knowledge creation through active research and encourage publications in reputed journals, incentives would be paid to faculty as detailed below w.e.f 1st April, 2019:

The claims for payment of incentives would be processed as per the following guidelines:

- The research papers published with IPE's affiliation will only be considered.
- Incentives can be claimed upon publication of the papers in the notified journals
- Incentives would be disbursed as follows for all categories of journals:
 - (a) Single author : 100%
 - (b) Multiple authors : to be equally distributed among authors
- For papers jointly written by a student and faculty, only faculty will get the incentive.
- Research associates / assistants will also be eligible for incentives under this policy.
- In case of papers jointly written by two or more faculty from different institutes, the award of incentive will be paid only to IPE faculty on prorata basis.
- The published papers are to be mailed to research@ipeindia.org (Research Division).
- Processing of incentives would be done on quarterly basis each financial year.
