- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **UAS International A Unit of United Accrual Services Pvt. Ltd.**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Institute of Public Enterprise** or **UAS International A Unit of United Accrual Services Pvt. Ltd.** after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **The Parties** are acting under this MOU as independent contractors, and the relationship under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name, to make representations or create any obligation or liability, expressed or implied, on behalf
